West Harlem Development Corporation (WHDC) is issuing a Request for Proposals (RFP) for an Affordable Housing Administrator (Housing Administrator). The Housing Administrator will be responsible for managing an affordable housing program to benefit Manhattan Community District 9 (MCD9). The deadline to submit an Intent to Submit a proposal is Monday May 12, 2014. The deadline to respond to the RFP is Friday July 18, 2014. WHDC invites qualified nonprofit organizations and community development entities to submit descriptions of their qualifications to supervise the development and/or rehabilitation of affordable housing in MCD9. The Housing Administrator cannot also serve as the developer or rehabilitator.
